

### Installation

Remove all packaging and insert 3 x AA 1.5V alkaline batteries (not included), ensuring batteries are inserted in the correct polarity. Once the batteries are installed the unit will run a self-test and a succession of three short audible beep tones indicate that it has activated and is working correctly. Each time the unit completes its duty cycle and emits ultrasound the red LED on the front panel will light up. The LED is a visual indication that the unit is working correctly and it will allow you to locate the unit and confirm that it is operating in dark, or out-of-reach areas. NOTE: The Anti Mouse Battery Powered Mouse Repellent will produce a recurring beep when the battery power becomes too low to operate effectively, even though the LED indicator may continue flashing intermittently.



To maximise the performance

Leave the unit operating continuously for 24hr protection, 3 x AA alkaline batteries will provide sufficient power for the unit to operate for at least 3 months. Make sure food is stored out of reach of rodent pests. Find and repair any openings where rodent pests can get in. Avoid installing the unit in areas where furniture and other household items may obstruct the ultrasonic signal.

#### **Important**

Do not tamper with the unit. For indoor use only.

Do not cover the unit or place it near direct sources of heat such as radiators. cookers and other appliances including refrigerators.

Do not use the unit if there are signs of damage.

Do not use the ultrasonic repellent unit around rodent pets such as hamsters. gerbils, guinea pigs, rabbits etc.

# How Does The Ultrasonic Mouse Repellent Work?

The unit emits powerful sound waves at a frequency that rodent pests can hear but which are not audible to humans. Rodents are disturbed by the ultrasound and will move out of the treatment areas.

#### What Areas Will The Unit Protect?









A single unit will protect one treatment area. For large or irregular shaped treatment areas, more than one unit may be required. Living areas and buildings with hard surfaces are ideal environments in which to use the Anti Mouse Battery Powered Mouse Repellent. Avoid installing the unit in areas where furniture and other household items may obstruct the ultrasonic signal.
